At the LHFIG the following Bulford Parish Council requests were discussed: The double yellow lines are now in place at both roundabouts however, an error has missed the stretch on High Street leading to Double Hedges. This will be rectified, and the lines will be in place soon. Obscuration issues on the approach to Junction 16 particularly from the direction of the Rose & Crown was discussed. It was suggested that a Road Safety Audit (RSA) should take place. Once the funding is confirmed the survey will take place. Bulford Parish Council would be liable to contribute £25% towards to the cost of the RSA. After discussion Council agreed to a pay the contribution due to the ongoing safety concerns junction 16.
